Submissions Policy

ASPI Blog welcomes submissions of approximately 400 . 600 words of considered analysis, images, statistics and graphs related to defence and strategic policy.

ASPI will accept, for consideration only, longer pieces but may, in consultation with the author, publish them serially or in part. However, since ASPI has many avenues for publishing longer more complex pieces, the aim of material written for the blog should be to present one or two pertinent observations, facts or opinions, with enough context to make them relevant to a wider policy discussion.

All material submitted to the ASPI Blog should be original, and the author(s) agree to transfer the intellectual property rights to ASPI for the article in question.

ASPI places no restriction on your right to produce and publish material on similar *topics* to that of the article submitted to the ASPI Blog ("**the Submitted Work**"). However, by submitting the Submitted Work for consideration with ASPI you agree not to submit for publication any material with substantially similar *content* as the Submitted Work for a period of three months from the date the Submitted Work is published on the ASPI blog, unless you first obtain the written consent of ASPI.

In some instances ASPI may publish the Submitted Work elsewhere, but will do so with full attribution of the author(s) and noting the ASPI Blog as the original source.

In addition, you agree, in respect of any part of the Submitted Work in which you do not own copyright, to reasonably assist ASPI to obtain permission from the owner of the copyright to use that part of the Submitted Work.

Authors must disclose any commercial relationships, affiliations or conflicts of interest.

Editorial policy

The editors of the ASPI Blog reserve the right to edit the Submitted Work.

In the event that any Submitted Work is edited for reasons of style or brevity or other reason, the author(s) will be provided with the edited form for comment or further discussion at which stage the author can opt to withdraw the article.

The editors of the ASPI Blog will reject any Submitted Work that:

1. does not further the discussion of defence and strategic policy;
2. is in poor taste;
3. which contravenes Australian defamation or vilification laws; or
4. in the judgement of the editorial staff of the ASPI Blog, for any other reason if the content is deemed inappropriate for publishing.

Anonymity

As a general rule, and consistent with ASPI's policies for other publications, ASPI's Blog will not accept submissions from authors who wish to remain anonymous.

In exceptional circumstances ASPI will waive this constraint, provided that the reasons for anonymity are sound and the analysis is deemed a worthy contribution to thinking and discussion within ASPI's scope.

Comments Policy

ASPI Blog encourages responses to posts, either in the form of short remarks, or in the form of additional blog posts of our standard length, (either form being the "**Response**") which will be subject to the same conditions for submissions as outlined above.

Readers will not be able to post their Responses directly on the ASPI Blog. All comments will be directed to the editors, and will be considered for publication subject to the same editorial quality control mechanisms as the longer posts.

If the editors of the ASPI Blog edit the Responses, wherever possible, the author(s) of the Response will be provided with the edited form in advance of publication. Please note that the turn-around time may be less than twenty-four hours.

Readers must disclose any commercial relationships, affiliations or conflicts of interest.

User Warranties

Authors warrant that any and all submissions (whether in the form of Submitted Works or Responses) have been prepared with due care and diligence.

Authors agree to indemnify and hold ASPI harmless against any and all liability, loss claim, judgment or damage. This indemnity includes, but is not limited to an indemnity against all actions, claims and demands (including the cost of defending or settling any actions, claim or demand) which may be instituted against us, as well as all expenses, penalties or fines (including those imposed by any regulatory body or under statute).
